Public discussion and/or comments from the floor:

John McVickers and John Thompson, Thompson Development – we are both here today to ask you to consider to change the contract that we have to purchase the village hall regarding the access to the site. We have been discussing this change with the attorney. Currently, access to the site right now is on the corner of Route 120 and Centre Drive. In order to develop the site we will need two access points on Centre Drive. The Village of Hainesville doesn't own Centre Drive so we cannot use that road for access onto the site. They are requesting the village to consider a modification to their contract to extend for another 30 days and have a right to walk away, which clearly they don't want to do.

Russ Kraly exited chamber council at 7:04 p.m.

John McVickers hopes that we will consider modifying the contract to get access to modify the site. Mayor Mueller stated we would be discussing this in executive session and then go back into our meeting to ask for a vote on this.

Russ Kraly and Kevin Barrett entered the chamber council at 7:05 p.m.

Lynn Tiffany, 514 Deer Crossing, Hainesville, IL 60073 – asked about the panel for the school. It is taking 15 to 20 minutes to get out of the school parking lot. People are turning around by the old florist shop. Mayor Mueller stated that the file has been turned over to Kathy Metzler and she will contact people. Mayor Mueller stated he worked hard on this issue before. Senator Adeline Geo-Karis allocated \$150,000. of her discretionary funds and Chief Johnson did a traffic study. Now the process has to start over. The mayor stated he investigated a caution light that is on Route 176 which has a crosswalk marked off. Mayor Mueller spoke to IDOT and Hainesville wouldn't qualify because you need one child to cross the street. Trustee Little stated that the school doesn't allow a child to walk across the highway. Trustee Little also asked why the panel file was turned over to the clerk? Mayor Mueller stated that Kathy is going to coordinate it for him. Trustee Little asked if Kathy will work with Mark and Kevin who worked diligently on this this past year? The Mayor stated yes, and with the present workload it is moving a little slow.
