December 13th, 2005 Public Hearing to Approve a Proposed Property Tax Levy Increase Meeting Minutes

Meeting called to order at the Village of Hainesville Council Chambers by Mayor Ted Mueller at 6:48 p.m.

Commander Mike Robinson and Officer Joe Segreti entered the Council Chamber at 6:50 p.m.

Proposed Tax Levy Ordinance for the Fiscal Year May 1st, 2005 and Ending April 30th, 2006

Treasurer Kelly Hensley explained the Proposed Tax Levy Ordinance which is required every year. Kelly reported that from last years tax bill total to this year tax bill total on a \$150,000. home the proposed tax increase would be approximately \$21.50 for a \$200,000. home it would be \$28.67, for a \$265,000. it would be \$37.98 and for a \$300,000 it would be \$43. This is based on the rate of .657 increase which was our maximum that we could go to. That includes corporate and police total.

Discussion took place.

Public Comments

Georgeann Duberstein, 82 Tall Oak Drive, Hainesville, IL 60073 – asked what is the difference that the police are requesting from what the budget was last year to what it is this year? Mayor Mueller stated we have an Intergovernmental Agreement with Round Lake Park covering the ratio of shared cost of police service and it is based on the number of calls to Hainesville and Round Lake Park.

Discussion took place.
